COVID FINANCIAL SUPPORT

The House Corporation has been working very closely with the current House leadership in navigating the impact of the Covid-19 pandemic on a wide variety of issues. We have been very impressed by their level of planning, commitment and sacrifice to ensure the safety of its members and the community, as well as compliance with University and Charlottesville regulations. To date, there have not been any widespread infections, and the House has not been cited for any violations.

With that said, there has been an impact to the House's financial condition that warrants our request for alumni support. Given the prohibition of groups in excess of ten people and the risk of hosting a super spreader event, activities within the House have been essentially eliminated. As such, the House Corporation elected to reduce the parlor fees being charged for the fall Semester. We also took into consideration that many actives are not able to have part-time jobs this semester, nor were they able to work over the summer as they did in prior years.

Given a corresponding a reduction in some expenses, we took this action in a generally budget-neutral way. However, based on the prospect of continuing restrictions through at least the early part of the spring semester, which will also likely impact the number of pledges, we expect that the House will experience a net operating loss for the year. Budgeting in this environment can be tricky, but we could experience a shortfall in the \$10,000 to \$20,000 range. The House Corporation does have some reserves to offset most of this loss, but we want to preserve that account to the extent possible as the number of active brothers could be materially lower for a period of time.

Since its founding nearly 150 years ago, Phi Society has survived two World Wars, the Great Depression, and even the end of Easters. So, we are not ready to let Covid-19 be the cause of our demise. We know that many of you have suffered financially from the pandemic, but we also know that some of you have not been as adversely affected. For the latter, we are asking you to make a commitment to help protect our future. Our goal is to raise at least \$10,000. See more on how to support the Phi House Fund on page eight.

RUSH

It is expected that the spring semester will look very similar to this fall, with continued restrictions on social gatherings. As a result, rush will likely be held entirely online. Given the difficulty of meeting potential rushees under the current circumstances, I appeal to our alumni. ANNUAL REPORT TO VIRGINIA BETA ALUMNI

On behalf of the Virginia Beta Board, I am pleased to report that the Fraternity continues to maintain an active membership of some 45 undergraduates and the premises at One University Circle remain situated in good condition. Given the Covid situation at the University, many changes from normal fraternity life have been put into place. No social functions are taking place (University wide) and the actives are paying reduced parlor dues (for operational expenses) and no social dues. Rentals of rooms to twelve actives and the meal plan program remain in place.

FINANCES AND DONATION GIVING

The House is operating on a reduced budget of some \$156,000 funded by rent (\$60,750) from actives living in and parlor dues (\$ 46,500). Social dues of \$48,750 are included in the revenue, however are zeroed out in the expenses as no social activity is taking place this semester due to Covid. The Virginia Beta Board, due mainly to the efforts of Trustee Matt Grossman '91, has been able to balance the budget during this fall semester, however, it is anticipated that a deficit will arise during the spring 2021 semester.

Some \$79,236.29 remain invested in Funds under the auspices of the UVA Fund at Alumni Hall and a small reserve remains in the Major Management Reserve. Since January 1, 2019, \$16,675 has been received in gifts from Virginia Beta alumni, parents and friend. See box on page eight.

As set out in the Appeal Letter on page eight, all alumni are urged to contribute to either the Phi House Fund or the Phi Educational Endowment Fund. The former is used for attending to annual maintenance and capital repairs and the latter is used to provide educational assistance. Both Funds are main-

RUSH

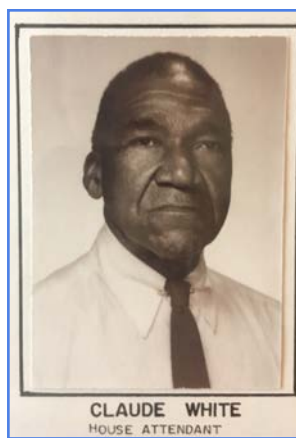
