ANNUAL REPORT Fiscal Year Ended June 30, 2016

Fellow Members of the Mystic Order,

There were over 100 Elis on hand October 29 for this year's gridiron garden party, held once again behind Pavilion VIII. The event was preceded by a visit to the Rotunda's newly dedicated East Courtyard, where an engraved footstone will permanently commemorate the leadership contribution of Eli Banana to the Rotunda Renovation campaign. Grand Banana Drew Ricciardone '17 encouraged all assembled to kiss the hallowed ground. To those who have pledged your support but have yet to visit, rest assured that the courtyard is a beautifully rendered outdoor extension of the elegance radiating from The University's rejuvenated centerpiece. The layout, fountain, and landscaping were overseen by Laurie Olin, recipient of the Thomas Jefferson Medal in Architecture.



Since its inception in 2008, The Eli Banana Fund has offered growing support to the University. Our Society, founded in 1878, may be the oldest on Grounds, but the Fund is a new kid on Grounds. There is reason to be optimistic about its prospects; individual Eli alumni are among the most generous givers to The University. This is a vehicle from which to contribute as a group to causes that match our mission, a mission supportive of traditions distinctive to UVA. The Fund has made gifts of \$100,000 to both Historic Preservation and the South Lawn project, and a \$600,000 gift to the Rotunda restoration, announced on May 12 and recognized in the East Courtyard (aka Darden Court).
