Annual Report

Fiscal-Year Ended June 30, 2019

The fiscal-year that ended June 30, 2019, was another successful year for both Eli Banana and the Eli Banana Fund ("The Fund"). The current members of Eli on the Grounds are growing, and our organization retains its historic significance and prestige within the Greek system. Socially, we had a busy year. In October 2018 over 200 Elis attended the 140th Anniversary of our mystic order at Alumni Hall. The Foxfield races were well attended by the current Elis as well as a few more "experienced" alumni. This past October, we held another successful Whiskey Conference in the garden behind Pavilion IX.

As everyone is aware, the University is undertaking a massive new fundraising effort. The Fund has been a significant supporter of University needs. Since commencing the Fund after the 125th Anniversary of the founding of Eli Banana, our generous members have raised and donated nearly \$2.8 million to the Fund. Our current balance stands at over \$1.4 million (managed by UVIMCO alongside all other University investments), and we have provided support to the University as noted below.

- \$600,000 to rebuild the East Garden at the Rotunda. There is a large engraved paver in the garden recognizing the support of Eli Banana. Our donation was one of the major contributions to the restoration of the Rotunda.
- 2. \$300,000 to Alumni Hall through the purchase of advertising in the Virginia Alumni Magazine and the payment of annual fees to support the management of the Alumni Association.
- 3. \$200,000 to the Eli Banana Fund for the historic preservation of the University.
- 4. \$150,000 to establish the Eli Banana Scholarship Fund as well as other initiatives to support the Greek system at the University.
- 5. \$100,000 to the South Lawn project.
- 6. \$50,000 to support the Pavilion series of seminars that seek to generate civilized discourse on current topics.

As you can tell from these donations, the main goals of the Eli Banana Fund are preservation of the historic University and support of the entire Greek system. We believe that these are worthy causes that often escape the traditional sources of funding at the University.

We intend to participate in the University's new initiative while providing our Eli alumni a way to focus their gifts on the priorities that the Fund supports. Our near term goal is to grow the Fund balance to \$3.0 million. This will allow us to increase

our visibility at the University and to double our annual support of the University without having to reduce the corpus of the Fund.

As you consider support for the University, we sincerely hope that you will consider the Eli Banana Fund as a steward for your donation. All contributions to the Eli Fund are counted as donations to the new University fundraising effort.

Our annual Whiskey Conference and our large reunions are not only great fun and a chance to maintain lifelong friendships, but provide an important basis for your continuing attachment to the University and for the difference that both Virginia and Eli Banana have made in our lives. We urge you to attend these events to reexperience the great conviviality that you remember from your days marching through the night to the beat of a large bass drum echoing in our ears.
